To qualify for a police/fire department rate, an individual must qualify under the following:

At least one guest in the stateroom must be an active, retired, or volunteer employee of a city or state/province/county law enforcement agency (state corrections officers and state prosecutors DO NOT qualify, i.e., District Attorney, Attorney General), fire department, or Emergency Medical Services (EMT - Emergency Medical Technician) in the state of California.

Qualified guests must present valid proof of employment (badge or ID) issued by a city or state/province law enforcement agency, fire department, or Emergency Medical Services (EMT - Emergency Medical Technician) in the United States (including U.S. Territories), plus a second form of identification when boarding the ship. The offer is not valid where restricted by applicable law. Retired employees must produce authoritative proof in the form of a company I.D. Badge or correspondence from a Human Resource Department of the company from which the employee retired.

To qualify for a military rate, an individual must be classified as one of the following:

- Active personnel currently serving in the United States Army, Navy, Air Force, Marines, Coast Guard, National Guard or Reserves. Proper identification in the form of a United States Uniformed Services WHITE or GREEN Identification Card for U.S. military personnel.
- Retired from any of the divisions listed directly above. "Retired" is defined as A) enlisted personnel or officers with a minimum of 20 years of service, B) medically retired, or C) 100% disabled. Proper identification for those classified in category A, or B must be in the form of a United States Uniformed RED (Reserve retired personnel) or BLUE (Active Duty retired personnel) Identification Card. Proper identification for those classified in category C is a United States Uniformed TAN Identification Card.
- Veterans with an Honorable Discharge serving a minimum of 2 years, or 6-months in an active war zone, in any of the United States service divisions listed above. For United States personnel, proper identification in the form of a DD214 (NGB 55 Form can be used in place of the DD214) or DD256, plus a current photo must be presented at time of check-in.
- **Spouses** of actively deployed military personnel are eligible to book one stateroom as long as the eligible spouse is occupying the stateroom. This rate also applies to all other guests traveling in the same stateroom. Spouses of deceased military personnel are also eligible for the military rate. As proof of eligibility, spouses must present the Pink or Tan Dependent Military ID upon check-in.

All guests traveling in the same stateroom are eligible to receive the military offer. No additional staterooms, other than the one that is occupied by the military person is eligible for the military offer. Parents, in-laws, children or other family members or friends are not eligible for the military person occupying the stateroom.

Extended Terms and Conditions

Cruising For Heroes Offer applies to select 2-night Celebrity Millennium sailings departing 3/21/20, 3/27/20, 3/29/20 and 4/4/20 At least one guest in the stateroom must be an active, retired or veteran member of the United States Military or State of California first responder including paid or volunteer Firefighters, Police Officers, Sheriffs and Sheriff's Deputies, California State Troopers, Federal Law Enforcement Officers EMTs/Paramedics and/or 911 Dispatcher. A valid U.S. military, police, firefighter or law enforcement ID must be presented at the pier to validate eligibility. If eligibility cannot be validated, you will be charged the current standard cruise fare or otherwise be denied boarding.
